1. To be eligible to run for the Board, you must have been an ordinary member for at least 30 days, i.e. by 12 February 2026.
2. No later than 14 days before the GA, you must submit your candidacy, i.e. by 28 February 2026, by sending an email to [info@sabaah.dk](mailto:info@sabaah.dk).
3. We will hold an online nomination meeting on 26 February from 17:30–19:00, where you will meet the current Board, who will talk about board work and answer questions. You may also submit your candidacy here. Please register no later than 26 February at 17:00 by writing to [info@sabaah.dk](mailto:info@sabaah.dk). You will then receive a link to the meeting.
